- All the bids filled on prescribed proforma should be duly endorsed, stamped, sealed and should comply with term and conditions.
- All the certificates pertaining to the registration of firm with tax authorities must also be enclosed.
- 05% of bid security shall be deposited along with the tender documents as earnest money in the form of Call Deposit Receipt (CDR)/Demand Draft/Pay Order issued by any scheduled bank of Pakistan in the name of Director General, NIPA, Lahore.
- Prices quoted should be inclusive of all applicable taxes which will be deducted by NIPA Lahore as per prescribed rules.
